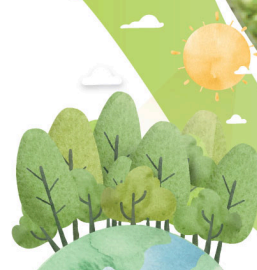

## INTRODUCTION

## OBJECTIVE

- ▶ Familiarize with environment management tools used in mitigating and/or solving environmental problems.
- ▶ strengthen decision making skills and in towards sustainable development.

## EXPECTED LEARNING OUTCOMES OF THE PROGRAMME

On completion of the programme the students are expected to:

- ▶ Equip with a sufficient theoretical knowledge, recognize and evaluate theoretical perspectives on the ecological and economic value of environment assets, their products and services.
- ▶ Acquire skills and technical ability to understand and successfully mitigate problems relating to sustainability of the environment with special reference to Sri Lanka.

## ADMISSION REQUIREMENTS

- (i) A Bachelor's degree from a recognized University/ Institution in Environment Management; OR
- (ii) Any other Bachelor's Degree, with prior learning/ work experience related to Environment Management; OR
- (iii) Postgraduate Diploma (SLQF 8) from a recognized University/Institution or an equal qualification acceptable to the Faculty Board and the Senate of the University with prior learning/work experience related to Environment Management; OR
- (iv) Professional qualification in Environment Management from a recognized professional body with acceptable to the Faculty Board and the Senate of the University with prior learning/work experience related to Environment Management; OR
- (v) Completion of NVQ level 7 (Equivalent to Bachelor's degree in SLQF) with prior work experience related to Environment Management as determined by the Faculty Board and the Senate of University of Colombo;

AND

- ⊗ A good knowledge of English language and satisfactory performance at a selection test and/or a selection interview.
- ⊗ Each application under clause (v) shall be considered on its merit.

Duly completed application form, certified copies of National Identity Card, birth certificate, relevant educational and professional qualifications, and work experience (if any) along with a scanned copy of the payment slip (of application processing fee) should be submitted via Apply Online weblink.
