**INTRODUCTION**

This is an interdisciplinary programme that focuses on ecological, legal, social, and economic aspects of environment management. The programme is designed to cater both armatures as well as professionals to develop their career in environment management.

**OBJECTIVE**

- ▶ Acquire skills and technical ability to understand and successfully mitigate problems relating to sustainability of the environment with special reference to Sri Lanka.

**ADMISSION REQUIREMENTS**

- (i) A Bachelor’s degree from a recognized University/ Institution in Environment Management; **OR**
  - (ii) Any other Bachelor’s Degree, with prior learning/ work experience in Environment Management; **OR**
  - (iii) Postgraduate Diploma (SLQF 8) from a recognized University/ Institution or an equivalent qualification acceptable to the Faculty Board and the Senate of the University with prior learning/ work experience in Environment Management; **OR**
  - (iv) Professional qualification in Environment Management from a recognized professional body which is acceptable to the Faculty Board and the Senate of the University with prior learning/ work experience in Environment Management; **OR**
  - (v) Completion of NVQ Level 7 (Equivalent to Bachelor’s degree in SLQF) with relevant work experience in Environment Mangement as determined by the Faculty Board and the Senate of the University; **AND**
- ⊗ A good knowledge of English language and satisfactory performance at a selection test and/ or a selection interview.
  - ⊗ Each application under clause (v) shall be considered on its merit.

Duly completed application form, certified copies of National Identity Card, birth certificate, relevant educational and professional qualifications, and work experience (if any) along with a scanned copy of the payment slip (of application processing fee) should be submitted via Apply Online weblink.
